**Subject** Sharp HealthCare Mandatory 2017 Flu Vaccination Program

Sharp HealthCare has implemented mandatory flu vaccinations for all Sharp HealthCare employees, volunteers, vendors, contractors, students and instructors. The 2017 Flu Season is scheduled to be in effect **November 1, 2017 through April 5, 2018**

All students who are coming to Sharp facilities must provide proof of flu vaccination: Flu Vaccination documentation must be **clear** and include:

- Student's name
- Name of provider
- Date given
- If providing proof via immunization records, be sure all pages are provided

In order to receive Sharp's FLU 2017 sticker, bring student ID badge along with documentation - in person - Monday through Friday to any of the following Sharp Employee Occupational Health Departments (EOHD):
