

PGY2 Ambulatory Care Residency Program

The PGY2 residency program in ambulatory care is designed to transition PGY1 residency graduates from a generalist practice setting to a specialized practice specific to the needs of ambulatory patients. The program is a collaborative effort between Sharp Rees-Stealy Medical Group and Touro University California to expand pharmaceutical care and existing teaching programs to pharmacy students completing their clinical clerkships in San Diego, CA.



Training sites for the residency program are primarily located at the Sharp Rees-Stealy Medical Centers throughout San Diego County, but also include facilities within the Sharp HealthCare integrated health system. The resident is expected to assume the role of a clinical ambulatory care pharmacist with focus on medication management within a variety of ambulatory settings. In addition, the resident will have opportunities to practice and refine teaching skills, research, and practice management skills through precepting of pharmacy students, conducting clinical research projects, and assisting in the development of clinics integrating clinical pharmacists. For those interested in further developing their teaching skills, participation in a teaching certificate program is available through the San Diego Pharmacy Residency Leadership (SDPRL) Teaching Program.

Curriculum

Clinical rotation schedules will be tailored to meet the resident's needs and career goals. The resident will be given opportunities to choose from the following clinical rotations and experiences, in addition to potentially establishing new clinical opportunities:

- Endocrinology
- Cardiology
- Pulmonology
- Family Medicine
- Managed Care
- Informatics
- Psychiatry
- Health Plan / Pharmacy Benefits
- Emergency Medicine
- Specialties/Home Infusion / Hospice
- Allergy / Immunology
- Infectious Disease
- Administration
- Neurology
- Other: Oncology, Transition of Care

Additional longitudinal experiences include: Anticoagulation clinic, lipid management clinic, refill management clinic, smoking cessation education, Western States research project, clinical outcomes research, pharmacy clinic development and precepting/teaching opportunities.

Qualifications

The applicant must have a Doctor of Pharmacy (PharmD) degree from an ACPE accredited pharmacy school and completion of a PGY1 pharmacy residency.

Deadline for applications is **January 9th, 2015**. If applicable, applicant(s) should be ready to sit for the board exams on or before July 31st, 2015.
